Tips for Submitting Your Application:

- Prepare all your materials in advance. Dance/NYC estimates that applicants of the Tier I individual dance makers application may need approximately 2-3 hours to complete their application if they have the information required readily available, and applicants of the Tier II small-budget dance making organizations/groups may need approximately 3-4 hours to complete their application if they have financial records readily available.
- Read the technical assistance offerings outlined below.
- Review all materials provided thoroughly before reaching out to the Dance/NYC team with additional questions. Often your question is answered within!

One (1) 40-minute session assisting with the completion of the application on Submittable. Priority for 40-minute sessions will be given to disabled applicants and/or applicants who do not have access to Wi-Fi and/or a computer for the purposes of submitting an application. Please register for only one session, at least two (2) business days in advance.

ASL interpretation and closed captioning will be available upon request at the time of registration. If you anticipate needing any of these services, please register at least five (5) business days in advance.
